Documentation must be original or a copy certified directly by the issuing institution. Documentation received will not be returned. If any of the below documentation is in a language other than English, it must be accompanied by a translation prepared and certified by an official translator.

- ☐ Course by course education evaluation report for every foreign law school attended.
- ☐ Official, final transcripts from all foreign undergraduate and foreign law schools attended. Transcripts must show the dates of attendance, the courses taken, the degree awarded and the date the degree was awarded. Transcripts must be received in envelopes sealed by the issuing institution. Transcripts received unsealed must be accompanied by an affidavit attesting that the transcript is the original that was received by the issuing institution and that it has not been altered, changed or otherwise modified by you or any other person.
- ☐ Copies of all diplomas or degree certificates from all foreign undergraduate and foreign law schools.
- ☐ Official transcript from the law school at which you received your LL.M. degree or are currently enrolled in an LL.M. program, or a statement explaining your intention to obtain an LL.M. degree in accordance with Article II-3 (B) of the CBEC Regulations.
- ☐ Certified check or money order for \$500.00 made payable to "Connecticut Bar Examining Committee."
